### **Waiver, and Release of All Liability & Assumption of Risk Agreement**

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in the Hogs n' Dogs Pageant & Costume Contest, I, for myself, my successors, heirs, assigns, executors, administrators, spouse, and next of kin:

1. Agree that, prior to participating I will inspect the facilities, equipment and areas to be used, and, if I believe that any of them are unsafe, I will immediately advise the person supervising EVENT, facility, activity, or area;
2. Acknowledge that I fully understand that my participation (and my dog's participation) may involve risk of serious injury or death, including economic losses, which may result not only from my own actions, in-actions, or negligence, but also from the actions, in-actions, or negligence of others, the condition of the facilities, equipment, or areas where EVENT or activity is being conducted, the rules of play, or this type of EVENT or activity;
3. Assume any and all risk of bodily injuries to myself (and/or my dog(s)), including medical or hospital bills, permanent or partial disability, death, and damages to my property, caused by or arising from my participation in EVENT or activity;
4. Covenant not to sue or present any claim for personal injury, property damage, or wrongful death against the Hogs n' Dogs Pageant & Costume Contest Committee, Grand Central District Association, Event sponsors and businesses located in the EVENT area, their officers, employees, volunteers for damages attributable to my participation in EVENT or activity;

Release, waive, discharge, and relinquish the Hogs n' Dogs Pageant & Costume Contest Committee, Grand Central District Association, Event sponsors and businesses located in the EVENT area, their officers, employees, volunteers from any liability, loss, damage, claim, demand, or cause of action against them arising from or attributable to my participation in EVENT or activity, whether same shall arise by their negligence or otherwise;

6. Agree that photographs, pictures, slides, movies, or videos of me and/or my pet(s) may be taken in connection with my participation in EVENT or activity without compensation and consent to the use of these photographs, pictures, slides, movies or videos for any legal purpose;

7. Warrant that my dog and I are in good health and have no physical conditions that prevent us from participating in this event or activity, and that my dog is fully immunized as required by local, state and federal law.

8. Event if rain or shine.

9. No refunds.

10. I hereby affirm that I am at least 18 years of age and fully competent; I agree to comply with the rules and regulations specified herein; and I have read, understand and voluntarily sign the Waiver, and Release of All Liability & Assumption of Risk Agreement.
